What Is The International Training And Exchange Program?

The Federal Mediation and Conciliation Service (FMCS) International Training and Exchange Program responds to a growing number of requests from agencies and institutions of friendly foreign governments for services in labor and non-labor relations conflict resolution. Dispute resolution involves a joint problem-solving approach designed to avoid formal and expensive litigation. It utilizes a neutral third party to help disputants find mutually acceptable solutions to problems arising in the workplace. It is used widely in the United States to resolve family, neighborhood, environmental, intergovernmental, legal, and workplace disputes and has become the preferred choice in working toward settlement.

FMCS International Services and Role?

FMCS plays an important role in promoting collective bargaining and conflict resolution in other nations. Emerging democracies often struggle to compete effectively in an integrated global marketplace. Establishing a competitive economy often depends on the role and structure of a country's labor relations systems. FMCS assists other countries in developing sound and stable labor relations through training in dispute resolution systems, collective bargaining and mediation. The programs include:

- **Dispute Systems Design:** Designing systems that resolve and prevent industrial conflict where a formal system has not been developed to manage it.
- **Education and Mentoring:** Training representatives of labor, management and government in industrial relations practices, mediation techniques, negotiation skills, and conflict resolution processes.
- **Mediation and Facilitation Services:** Assisting in a consensus-building dialog that promotes economic growth and legal or institutional reform.

FMCS has provided conflict resolution services to the governments of Peru, Argentina, Brazil, Canada, Colombia, Serbia, Bulgaria, Mexico, Ireland, Panama, Kenya, Tanzania, Uganda, Mozambique, Kashmir, Indonesia, Croatia, Lithuania, Latvia, South Africa, South Korea, and Thailand.
